## RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO ICT CLOVERLEAF TRADING OPC FOR THE SUPPLY AND DELIVERY OF VARIOUS OFFICE EQUIPMENT INTENDED FOR THE OFFICE OF THE CITY TOURISM OFFICER

WHEREAS, there is an approved Purchase Request (PR) No. 100-2025-01-119 with an Approved Budget for Contract (ABC) of Two Hundred Thirty-Two Thousand Eight Hundred Pesos (PhP 232,800.00) for the above stated procurement;
