## **RESOLUTION NO. 137B - 2025**

RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO PJMJ TRADING AND CONSTRUCTION FOR THE SUPPLY AND DELIVERY OF COLLAPSIBLE TENT 3M X 6M, MONOBLOC CHAIR WITH BACK REST, ETC., INTENDED FOR THE OFFICE OF THE CITY ENGINEER
