RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO PUERTO PRINCESA CITY GOVERNMENT EMPLOYEES MULTI-PURPOSE COOPERATIVE FOR THE SUPPLY AND DELIVERY OF MEALS AND SNACKS INTENDED FOR THE OFFICE OF THE CITY MAYOR

WHEREAS, there is an approved Purchase Request (PR) No. 100-2025-02-298 with an Approved Budget for Contract (ABC) of Nine Hundred Ninety-Nine Thousand Nine Hundred Fifty Pesos (PhP999,950.00) for the above stated procurement;
