## **RESOLUTION NO. 0770 - 2025**

RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO PALAWAN OPERATORS TOURIST MULTI-PURPOSE COOPERATIVE FOR THE SUPPLY AND DELIVERY OF TRANSPORTATION RENTAL INTENDED FOR THE OFFICE OF THE CITY MAYOR – MIMAROPA REGIONAL ATHLETIC MEET 2025

WHEREAS, there is an approved Purchase Request (PR) No. 100-2025-02-308 with an Approved Budget for Contract (ABC) of Five Hundred Forty Thousand Pesos (PhP 540,000.00) for the above stated procurement;
