## **RESOLUTION NO. 1941 - 2025**

RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO PUERTO PRINCESA CITY GOVERNMENT EMPLOYEES MULTI-PURPOSE COOPERATIVE (PPCG-MPC for brevity) FOR THE SUPPLY AND DELIVERY OF MEALS AND SNACKS INTENDED FOR THE OFFICE OF THE CITY PLANNING AND DEVELOPMENT COORDINATOR – OPERATIONAL SUPPORT FOR CITY STATISTIC COMMITTEE - CISC

WHEREAS, there is an approved Purchase Request (PR) No. 100-2025-02-333 with an Approved Budget for Contract (ABC) of Sixty-Four Thousand Seven Hundred Fifty Pesos (PhP64,750.00) for the above stated procurement;

WHEREAS, said item is included in the Annual Procurement Plan/ Project Procurement Management Plan of the City Government of Puerto Princesa (CGPP) for 2025;
