

RESOLUTION NO. 138P- 2025

**RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO
ICT CLOVERLEAF TRADING OPC FOR THE SUPPLY AND DELIVERY OF INSECTICIDE
(MALATHION), ETC., INTENDED FOR THE OFFICE OF THE CITY MAYOR – BALAYONG
PEOPLE'S PARK MANAGEMENT**

WHEREAS, there is an approved Purchase Request (PR) No. 100-2025-02-366 with an Approved Budget for Contract (ABC) of Two Hundred One Thousand Six Hundred Thirty-Three Pesos (PhP 201,633.00) for the above stated procurement;

WHEREAS, said item is included in the Annual Procurement Plan/ Project Procurement Management Plan of the City Government of Puerto Princesa (CGPP) for 2025;

WHEREAS, the Bids and Awards Committee (BAC) of CGPP was authorized to resort to Alternative Methods of Procurement in accordance with the provisions of Section 53.9 of the IRR of RA 9184 per Approved Annual Procurement Plan 2025 of the CGPP;

WHEREAS, the BAC has sent Request for Quotation (RFQ) indicating the specification, quantity, ABC, and other terms and conditions of the item/s to be procured to eligible suppliers;

WHEREAS, before the deadline for submission of price quotations, the return of the RFQs sent resulted to the following:



RESOLVED FURTHER, that copies of this resolution be furnished to the Office of the City Mayor, and other concerned offices for their information and/or appropriate action.






