RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO PUERTO PRINCESA CITY GOVERNMENT EMPLOYEES MULTI-PURPOSE COOPERATIVE (PPCGE-MPC for brevity) FOR THE SUPPLY AND DELIVERY OF MEALS AND SNACKS INTENDED FOR THE OFFICE OF THE CITY MAYOR – PUBLIC EMPLOYMENT SERVICE OFFICE (PESO)
