

**RESOLUTION NO. 161Y - 2025**

**RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO MEGAPRINT ADS AND TRADING FOR THE SUPPLY AND DELIVERY OF WATER PROOF BOOTS, LONG SLEEVE, FIELD PANTS, ETC. INTENDED FOR THE OFFICE OF THE CITY PUERTO PRINCESA SUBTARRANEAN RIVER NATIONAL PARK.**

**WHEREAS**, there is an approved Purchase Request (PR) No. 100-2025-02-497 with an Approved Budget for Contract (ABC) of Two Hundred Eighty-Five Thousand Two, Hundred Fifty Pesos (PhP285,250.00) for the above stated procurement;

**WHEREAS**, said item is included in the Annual Procurement Plan/ Project Procurement Management Plan of the City Government of Puerto Princesa (CGPP) for 2025;

**WHEREAS**, the Bids and Awards Committee (BAC) of CGPP was authorized to resort to Alternative Methods of Procurement in accordance with the provisions of Section 53.9 of the IRR of RA 9184 per Approved Annual Procurement Plan 2025 of the CGPP;

**WHEREAS**, the BAC has sent Request for Quotation (RFQ) indicating the specification, quantity, ABC, and other terms and conditions of the item/s to be procured to eligible suppliers;

**WHEREAS**, before the deadline for submission of price quotations, the return of the RFQs sent resulted to the following:


