**RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO
ICT CLOVER LEAF TRADING OPC FOR THE SUPPLY AND DELIVERY OF AIR
REFRESHENER, ALOCHOL ETHYL 68%-72% 1 GALLON, BLACK GARBAGE BAG MEDIUM
(11X11X24), ETC. INTENDED FOR THE OFFICE OF THE CITY HEALTH OFFICER**

WHEREAS, there is an approved Purchase Request (PR) No. 100-2025-04-903 with an Approved Budget for Contract (ABC) of Eight Hundred Twenty-Six Thousand Three Hundred Thirty-Nine Pesos and (03/100) Pesos (PhP826,339.03) for the above stated procurement;

WHEREAS, said item is included in the Annual Procurement Plan/ Project Procurement Management Plan of the City Government of Puerto Princesa (CGPP) for 2025;

WHEREAS, the Bids and Awards Committee (BAC) of CGPP was authorized to resort to Alternative Methods of Procurement in accordance with the provisions of Section 53.9 of the IRR of RA 9184 per Approved Annual Procurement Plan 2025 of the CGPP;

WHEREAS, the BAC has sent Request for Quotation (RFQ) indicating the specification, quantity, ABC, and other terms and conditions of the item/s to be procured to eligible suppliers;

WHEREAS, before the deadline for submission of price quotations, the return of the RFQs sent resulted to the following:
