

CONTRACT AGREEMENT

THIS AGREEMENT, made this ____ day of JAN '27 2025 2025 between the CITY GOVERNMENT OF PUERTO PRINCESA, represented by the Honorable City Mayor Lucilo R. Bayron, hereinafter called "*the Entity*" of the one part and L. B. LEONCIO TRADING AND CONSTRUCTION CORPORATION, with principal place of business located at North National Highway, San Manuel, Puerto Princesa City, herein represented by MR. LORENZO B. LEONCIO, hereinafter called "the Contractor" of the other part:

WHEREAS, the Entity is desirous that the Contractor execute **CONCRETING OF ACCESS ROAD FROM PUROK MAGSASAKA TO MANGINGISDA CEMETERY** project located at Barangay Mangingisda, this City (hereinafter called "the Works") and the Entity has accepted the Bid for **Twenty Million Two Hundred Eighty-Four Thousand Six Hundred Twenty-Seven Pesos and 49/100 (P 20,284,627.49)**. by the Contractor for the execution and completion of such Works and the remedying of any defects therein.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security; and
 - d. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Twenty Million Two Hundred Eighty-Four Thousand Six Hundred Twenty-Seven Pesos and 49/100 (P 20,284,627.49)**. or such other sums as may be ascertained, L. B. LEONCIO TRADING AND CONSTRUCTION CORPORATION agrees to **the CONCRETING OF ACCESS ROAD FROM PUROK MAGSASAKA TO MANGINGISDA CEMETERY** project located at Barangay Mangingisda, this City in accordance with its Bid.
4. The CITY GOVERNMENT OF PUERTO PRINCESA agreed to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The notarization of this instrument shall be on the account of the contractor.


