

RESOLUTION NO. 224Q - 2025

RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO PUERTO PRINCESA CITY GOVERNMENT EMPLOYEES MULTI-PURPOSE COOPERATIVE (PPCGE-MPC for brevity) FOR THE SUPPLY AND DELIVERY OF MEALS AND SNACKS INTENDED FOR THE OFFICE OF THE CITY HEALTH OFFICER – OFFICE OF THE CITY POPULATION CONTROL OFFICER

WHEREAS, there is an approved Purchase Request (PR) No. 100-2025-01-097 with an Approved Budget for Contract (ABC) of Two Hundred Ninety-Five Thousand Pesos (PhP295,000.00) for the above stated procurement;

WHEREAS, said item is included in the Annual Procurement Plan/ Project Procurement Management Plan of the City Government of Puerto Princesa (CGPP) for 2025;

WHEREAS, the Bids and Awards Committee (BAC) of CGPP was authorized to resort to Alternative Methods of Procurement in accordance with the provisions of Section 53.9 of the IRR of RA 9184 per Approved Annual Procurement Plan 2025 of the CGPP;

WHEREAS, the BAC has sent Request for Quotation (RFQ) indicating the specification, quantity, ABC, and other terms and conditions of the item/s to be procured to eligible suppliers;

WHEREAS, before the deadline for submission of price quotations, the return of the RFQs sent resulted to the following:

WHEREAS, the BAC, upon recommendation from the Technical Working Group (TWG) and upon due deliberation of the submitted RFQs, found that the offer of Puerto Princesa City Government Employees Multi-Purpose Cooperative the Lowest calculated and responsive quotation (LCRQ);

NOW THEREFORE, on the basis of the foregoing, it is **HEREBY RESOLVED** to recommend the award of contract via SVP to Puerto Princesa City Government Employees Multi-Purpose Cooperative for the above-quoted procurement of goods.


RESOLVED FURTHER, that copies of this resolution be furnished to the Office of the City Mayor, and other concerned offices for their information and/or appropriate action.


