

RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO
1CT CLOVER LEAF TRADING OPC FOR THE SUPPLY AND DELIVERY OF BIHON, CORN,
BEEF, CONDIMENTS, ETC. INTENDED FOR THE OFFICE OF THE CITY HEALTH OFFICERS
- OPERATION HALFWAY DROP-IN CENTER

WHEREAS, there is an approved Purchase Request (PR) No. 100-2025-06-1168 with an Approved Budget for Contract (ABC) of One Hundred Eighty-Five Thousand Seven Hundred Twenty-Four Pesos and 50/100 (PhP185,724.50) for the above stated procurement;

WHEREAS, said item is included in the Annual Procurement Plan/ Project Procurement Management Plan of the City Government of Puerto Princesa (CGPP) for 2025;

WHEREAS, the Bids and Awards Committee (BAC) of CGPP was authorized to resort to Alternative Methods of Procurement in accordance with the provisions of Section 53.9 of the IRR of RA 9184 per Approved Annual Procurement Plan 2025 of the CGPP;

WHEREAS, the BAC has sent Request for Quotation (RFQ) indicating the specification, quantity, ABC, and other terms and conditions of the item/s to be procured to eligible suppliers;

WHEREAS, before the deadline for submission of price quotations, the return of the RFQs sent resulted to the following:
