## CONTRACT AGREEMENT

THIS AGREEMENT, made this \_\_\_\_\_ day of 19 NOV 2025 2025 between the CITY GOVERNMENT OF PUERTO PRINCESA, represented by the Honorable City Mayor Lucilo R. Bayron, hereinafter called "*the Entity*" of the one part and BANGKAPRO AQUATICS, INC., with principal place of business located at Bay Breeze executive Village, Sandpiper Drive Corner Kingfisher Avenue, Hagonoy Taguig, Metro Manila, herein represented by MS. MARIA C. CANSEKO, hereinafter called "*the Contractor*" of the other part:


WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the Supply and Delivery of 1 unit Sea Patient Transport Watercraft (molded fiberglass hull and deck reinforced with gelcoat finish, max of 10-15 pax, etc.) has accepted a Bid by the Supplier for the supply of those and services in the sum of PESOS: Five Million Four Hundred Ninety-Eight Thousand Pesos (Php 5,498,000.00). (hereinafter called "*the Contract Price*").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract;
    - iv. Supplemental or Bid Bulletins, if any;
  - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - c. Performance Security; and
  - d. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of *Five Million Four Hundred Ninety-Eight Thousand Pesos (Php 5,498,000.00)*. or such other sums as may be ascertained, BANGKAPRO AQUATICS, INC. agrees to *the SUPPLY AND DELIVERY OF 1 UNIT SEA PATIENT TRANSPORT WATERCRAFT (MOLDED FIBERGLASS HULL AND DECK REINFORCED WITH GELCOAT FINISH, MAX OF 10-15 PAX, ETC.)* IN accordance with its Bid.
4. The CITY GOVERNMENT OF PUERTO PRINCESA agreed to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The notarization of this instrument shall be on the account of the supplier.
