

RESOLUTION NO. 171J- 2025

**RECOMMENDING THE AWARD OF CONTRACT VIA SHOPPING TO FUTURISTIC TRADING
& CONSTRUCTION FOR THE SUPPLY AND DELIVERY OF TIRES AND SPARE PARTS
INTENDED FOR THE OFFICE OF THE CITY VICE MAYOR**

WHEREAS, there is an approved Purchase Request (PR) No. 100-2025-07-1604 with an Approved Budget for Contract (ABC) of Ninety Nine Thousand Nine Hundred Ninety Nine Pesos and 20/100 (Php 99,999.20) for the above stated procurement;

WHEREAS, said item is included in the Annual Procurement Plan/ Project Procurement Management Plan of the City Government of Puerto Princesa (CGPP) for 2025;

WHEREAS, the Bids and Awards Committee (BAC) of CGPP was authorized to resort to Alternative Methods of Procurement in accordance with the provisions of Section 52.1 (a) of the IRR of RA 9184 per Approved BAC Resolution No. 250Q – 2025 dated August 27, 2025;

WHEREAS, the BAC has sent Request for Quotation (RFQ) indicating the specification, quantity, ABC, and other terms and conditions of the item/s to be procured to eligible supplier;

WHEREAS, before the deadline for submission of price quotations, the return of the RFQs sent resulted to the following:
