

**RESOLUTION NO. 331A - 2025**

**RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO PUERTO PRINCESA CITY GOVERNMENT EMPLOYEES MULTI-PURPOSE COOPERATIVE (PPCGE-MPC for brevity) FOR THE SUPPLY AND DELIVERY OF MEALS AND SNACKS INTENDED FOR THE OFFICE OF THE CITY ENVIRONMENT AND NATURAL RESOURCES OFFICERS**

**WHEREAS**, there is an approved Purchase Request (PR) No. 100-2025-08-1900 with an Approved Budget for Contract (ABC) of Two Hundred Twenty-Nine Thousand Four Hundred Pesos (PhP229,400.00) for the above stated procurement;

**WHEREAS**, said item is included in the Annual Procurement Plan/ Project Procurement Management Plan of the City Government of Puerto Princesa (CGPP) for 2025;

**WHEREAS**, the Bids and Awards Committee (BAC) of CGPP was authorized to resort to Alternative Methods of Procurement in accordance with the provisions of Section 53.9 of the IRR of RA 9184 per Approved Annual Procurement Plan 2025 of the CGPP;

**WHEREAS**, the BAC has sent Request for Quotation (RFQ) indicating the specification, quantity, ABC, and other terms and conditions of the item/s to be procured to eligible suppliers;

**WHEREAS**, before the deadline for submission of price quotations, the return of the RFQs sent resulted to the following:

**NOW THEREFORE**, on the basis of the foregoing, it is **HEREBY RESOLVED** to recommend the award of contract via SVP to Puerto Princesa City Government Employees Multi-Purpose Cooperative for the above-quoted procurement of goods.
