

**RESOLUTION NO. 368D - 2025**

**RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO MELDAVIDSON TRADING AND GENERAL MERCHANDISING FOR THE SUPPLY AND DELIVERY OF FLUSH TANK, URINAL FLUSH VALVE, ETC. INTENDED FOR THE OFFICE OF THE CITY MAYORS – PUERTO PRINCESA SUBTERRANEAN RIVER NATIONAL PARK**

WHEREAS, there is an approved Purchase Request (PR) No. 100-2025-11-2336 with an Approved Budget for Contract (ABC) of Seven Hundred Seventy-Six Thousand Three Hundred Forty-Three Pesos and 75/100 (PhP776,343.75) for the above stated procurement;

WHEREAS, said item is included in the Annual Procurement Plan/ Project Procurement Management Plan of the City Government of Puerto Princesa (CGPP) for 2025;

WHEREAS, the Bids and Awards Committee (BAC) of CGPP was authorized to resort to Alternative Methods of Procurement in accordance with the provisions of Section 53.9 of the IRR of RA 9184 per Approved Annual Procurement Plan 2025 of the CGPP;

WHEREAS, the BAC has sent Request for Quotation (RFQ) indicating the specification, quantity, ABC, and other terms and conditions of the item/s to be procured to eligible suppliers;

WHEREAS, before the deadline for submission of price quotations, the return of the RFQs sent resulted to the following:

NOW THEREFORE, on the basis of the foregoing, it is **HEREBY RESOLVED** to recommend the award of contract via SVP, to Meldavidson Trading and General Merchandising for the above-quoted procurement of goods.
