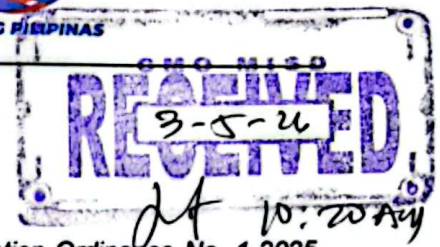

9. Bid opening shall be on the same date at 2:00 o'clock in the afternoon at the given address below. Bids will be open in the presence of the Bidders' Representatives who choose to attend at the activity.
10. All bids must be **COMPLETE**. *Partial bids* shall be considered *non-responsive* and, thus, automatically disqualified. In this regard, where a required item is provided, but no price is indicated, the same shall be considered as non-responsive, but specifying a "0" (zero) for the said item would mean that it is being offered for free to the CGPP.
